

Conditions for Rentals Pitches or Rental Accommodation



1. All rentals are by name only and may not be transferred or sublet under any circumstances.
2. The rental becomes effective only with the agreement and after reception of a payment corresponding to a deposit of 30% of the rental, to which should be added the rental fees, and the cancellation insurance (in case of subscription). If this payment is not made within 15 days of the booking date, the booking will be automatically cancelled.
3. Opening hours :
Campsite-Caravanning spots : Arrival : between 2 pm and 00:00 Departure : before 12:00 am
Rental accommodation : Arrival : between 3 pm and 00:00 Departure : before 10:00 am
4. Animals are allowed on the Camping Caravanning site (except category 1 and 2 animals) under the following conditions :
 - Pets must be kept on a leash
 - Access to the sanitary facilities and the beaches is forbidden
 - Pets must not be left alone
 - Vaccination certificate requiredAnimals are not allowed in the rental accommodation.
5. The number of people staying on the pitch or in the rental accommodation must not exceed the number indicated on arrival or authorised in the rental accommodation, even for one night. The person(s) concerned will be refused entry to Camping International de Jablines. It is forbidden to pitch a tent in the garden of the rental accommodation.
6. Fires on the ground are forbidden. Standing barbecues are allowed, with the usual precautions, outside the accommodation. Barbecues are available on site.
7. Any person coming to visit you must be declared to the office and must pay the current fee.
8. The swimming lake of the Base de Loisirs de Jablines-Annet is accessible free of charge for clients staying at the Camping International de Jablines*** according to the opening conditions and the internal regulations of the Base de Loisirs de Jablines-Annet. Underage children swim under the responsibility of their parents. Swimming with a wetsuit or burkini is forbidden. Only swimming trunks or shorts are allowed.
9. The balance of the camping-caravanning stay must be paid in full on the day of arrival. No discount will be given for late arrival or early departure. In the absence of a written message from the client, stating that he/she has had to postpone the date of arrival, the pitch becomes available 24 hours after the date of arrival stipulated in the rental contract.
10. The balance of the rental accommodation must be paid in full on the day of arrival. No reduction will be made for late arrivals or early departures. In the absence of a written message from the customer

stating that he/she has had to postpone the date of arrival, the pitch will become available 24 hours after the arrival date stated in the rental contract.

11. For rental accommodation, a deposit of €250 (credit card or cash only) will be required on arrival for mobile homes and €150 for bivouacs. The deposit will be returned in full within a week of departure, if no cleaning is required and if no damage or lack of equipment is noted.
12. Cancellation insurance is available for camping and caravanning pitches and rental accommodation. The insurance contract must be taken out directly with our partner insurer via our website.
13. In case of cancellation without insurance: no refund
14. In case of cancellation with insurance, you will be charged or still owe : the above-mentioned compensation for breach of contract, which will be reimbursed to you by the insurance company in accordance with the terms of the cancellation insurance contract.
15. It is the tenant's responsibility to be insured for civil liability. The campsite declines all responsibility in the event of theft, fire, bad weather, etc. and in the event of fire for which the tenant is liable.
16. The rules of procedure are displayed at the reception desk. Any person entering the Camping International de Jablines*** is required to respect them.
17. Personal data collected at the time of booking is processed solely for the purposes of managing stays and complying with legal obligations. In accordance with the GDPR, customers have the right to access, rectify, erase, restrict and object to the processing of their data.
